BRIEF COURSE DESCRIPTION

This self-study course meets the California Department of Real Estate's 45 hour course requirement and covers office procedures, duties and responsibilities of a real estate brokerage and salesperson. The course is 2 ½ weeks in duration and includes practices in listing agreements, purchase contracts, conflicts in agency, escrow, disclosures, and requirements for a real estate exchange. It also addresses ethics and compliance of state and federal regulations. This course is a mandatory requirement to the three courses required as a pre-requisite to taking the State licensing examination. The course provides the student with both a 45 hour, two and one-half (2 ½) weeks of self-study with a text book and an electronic online version. The course also includes 25 hours of optional lectures to assist those preparing for the California Real Estate sales license examination. The live classroom lecture/study group is designed to help the student complete their independent study of the course and prepare for the successful passing of the course final exam. To receive the required course certificate a passing grade of 75% is required. The course is facilitated by a licensed CA Real Estate Broker. The course final exam is a live proctored exam held at the Monrovia Community Adult School.
